AFFIDAVIT

In all I do, I will have to face my Creator to whom I owe my life and my being. In the depths of my nothingness, His Holy Word beckoned me to make a clean breast of everything - "THE TRUTH WILL SET YOU FREE".

- I, JANET LIM NAPOLES, Filipino, of legal age and presently confined at the Ospital ng Makati, after having been duly sworn to in accordance with law, hereby depose and state that:
- 1. I am one of the Respondents in OMB-C-C-13-0396, OMB-C-C-13-0318, OMB-C-C-13-0395, OMB-C-C-13-0316, OMB C-C-13-0397, OMB-C-C-13-0313, OMB-C-C-13-0314, OMB-C-C-13-0317, OMB-C-C-13-0319, OMB-C-C-0315, OMB-C-C-13-0320, OMB-C-C-14-0003, OMB-C-C-14-0018, OMB-C-C-14-0015, OMB-C-C-14-0017, OMB-C-C-14-0007, OMB-C-C-13-0357 and my all other cases pending before the Office of the Ombudsman; for violation of R.A. No. 7080, as amended (otherwise known as the Anti-Plunder Act), for violation of R.A. No. 3019 as amended (otherwise known as Anti-graft and Corrupt Practices Act) and for violation of Art. 172 of the Revised Penal Code.
- 2. I am executing this affidavit to shed light on the facts and circumstances surrounding the alleged Priority Development Allocation Fund (PDAF) and Malampaya Fund scams. This affidavit will also touch on the use of government funds like in the form of budget insertions and those coursed through the Department of Transportation and Communication (DOTC) and other transactions that I have personal knowledge of, but the details of which will be covered by another affidavit.

- 3. I am likewise presenting this affidavit to support my request for the exclusion of my children **James Christopher Lim Napoles and Jo Christine Napoles** from the above mentioned Complaints. My children had no knowledge, participation and involvement whatsoever in the subject cases. They had executed counter-affidavits to prove their innocence in the charges made against them.
- 4. We are also willing to help the government by offering to testify, based on our personal knowledge and information, in all other cases that the Department of Justice and the Office of the Ombudsman may file against those involved in the above mentioned transactions.
- 5. During the Senate Inquiry in November 2013, I opted to remain silent because at that time, I was still at a loss on what to do. Since, I did not have a counsel of my choice at the Senate, I was then assisted by a lawyer from the Public Attorneys' Office (PAO) whom I just met during the said inquiry. I wanted to talk to the Secretary of the Department of Justice, Leila De Lima, prior to my testimony in the Senate but various forces prevented me from doing so. Thus, my silence in the Senate Inquiry.
- 6. I became so careful in my dealings with other people because oftentimes, I found them just fishing for information for their personal agenda. Sometimes, people would come to us offering for help but ended up extorting huge amount of money. At various instances, there seem to be forces who want to make me a "scapegoat" of the scams uncovered by the COA, and divert public outrage towards me.
- 7. Since the hospitalization of my brother Reynald Lim y Luy and the filing of the Serious Illegal Detention case against him and myself in March 2013, my family and I started receiving threats from unknown sources through text messages using prepaid cellular phone numbers and anonymous letters. Our personal information (telephone numbers and email addresses) were posted on-line encouraging our detractors to harm or threat

us. In fact, unmarked vehicles and unidentified persons were doing surveillance work at our house and office, as well as in the residence of our relatives.

- 8. While I was being detained at Fort Sto. Domingo, and with the spiritual guidance of Archbishop Socrates Villegas, D.D. and the other priests who patiently and unceasingly pray and continued praying for me to tell the truth, I realized that indeed I should TELL THE WHOLE TRUTH.
- 9. By telling the truth, which the people have been clamoring and I have been wanting to do for a long time, I intend to help my country and work towards minimizing, if not totally eradicating corruption, so as not to put to waste these revelations.
- 10. Before undergoing surgery, God answered my prayer by giving me the chance to talk to the Honorable Secretary of Justice, Leila De Lima. And this bolstered my belief that indeed, TELLING THE TRUTH will set me free.
 - 11. Thus, I am executing this affidavit.

I AM NOT THE MOST GUILTY AND NOT THE "MASTERMIND" OF THE ALLEGED 10 BILLION PORK BARREL SCAM NOR OF THE MALAMPAYA FUND SCAM

- 12. I categorically and strongly DENY that I am the "mastermind" of the alleged Priority Development Assistance Fund (PDAF) or Pork Barrel and Malampaya Fund scams as well as other projects that used government funds of which I have personal knowledge of.
- 13. First and foremost, I am not capable and do not have the "skill" to run such a complicated scheme given my humble beginning. I am only an ordinary private businesswoman. I neither have the power nor the authority to order the Department of Budget and Management (DBM) to release documents as well as command the implementing agencies to choose any

foundation or Non-governmental Organization (NGO). Neither can I direct nor control any legislator to give me his or her PDAF and disburse it as I please. I also did not conceptualize the formation of NGOs as well as their functions. I am not and was never an elected official nor an accountable government officer or employee.

- 14. Second, the Priority Development Allocation Fund (PDAF) existed even as early as 1922. I was not even born then nor my parents. In 1922, it was named as the Public Works Act. Even as early as 1925, the misuse of the funds in the form of pork barrel was already questioned. The PDAF, as known today, evolved from Mindanao Development Fund and Visayas Development Fund in 1989, Countrywide Development Fund in 1990, then Congress Initiative Allocation before it was called the PDAF which we refer to today. Though it changed names over the years, the function and use of the said fund have remained the same.
- 15. Third, the Commission on Audit (COA) Report identifies at least 82 NGOs with anomalous or questionable transactions for just the years 2007-2009. I am not involved nor familiar with all of these NGOs. I did not create nor form all these NGOs such that one can conclude that I was the "brain" of using pork barrel or foundations in transacting with the government. I am absolutely sure that even before I entered into the business of transacting through NGOs or foundations, there were already existing foundations transacting with the government.

General Background of the Transactions

16. In my many years of being a businesswoman, I engaged in various businesses. In one of my ventures, I was the exclusive distributor of Nutrigrowth Philippines—a manufacturer of Liquid Foliar Fertilizers. After a few years, I was able to buy Nutrigrowth Philippines and became a

manufacturer of fertilizers. Later on, I decided to form Dragon 1.5 Mega Philippines after Nutrigrowth encountered some problems.

- Abad by Mr. Manuel Jarmin. We met at the Japanese Restaurant in Edsa Shangri-la Plaza Hotel. In that meeting, he told me about a project worth 10 million pesos. He showed me the Special Allotment Release Order (SARO) then explained to me what it was for. Before the meeting ended, I handed him Php 2 Million Pesos. When the Notice of Cash Allocation (NCA) was released, I gave him another Php 2 Million Pesos. Afterwards, when we talked about the implementation, he asked me if I had an NGO. When I told him I did not have an NGO, he told me he would take care of it. From what I recall, he used Batanes Electric Cooperative to implement the project. After some time, he returned the Php 4 Million Pesos I gave him with an added Php 2 Million Pesos more. That is when I started to transact using the PDAF.
- 18. I wanted to expand my business as well as the distribution of my goods just like any other businesswoman. To my confusion and surprise, the agencies did not transact directly with companies. Instead, they had various NGOs/Foundations at their control and disposal, which they offered for rent. Dennis Cunanan was one of those who offered various NGOs for rent, which can be used to implement projects in TLRC. However, I feared that these NGOs that they rented out had problems as I heard that the incorporators they use are either dead or not existing.
- 19. NGOs— Due to my fear, I wanted to make sure that the NGOs I will associate with legally complied with the laws including SEC as well as BIR requirements. That's why as far as I know, the NGOs I am associated with strictly complied with the registration and other requirements of the law. In addition to that, the agencies have strict rules and regulation as to the accreditation of NGOs before they enter into Memorandum of Agreement (MOA) with it. Thus, before an NGO can transact, the agency will have to

inspect and accredit the said NGO. For such reasons, as far as I know the NGOs I am associated with are legal and not bogus as alleged and highly publicized.

- 20. The agents— Since I have no capacity to know the projects of the agencies as well as the funding of the legislators, different agents representing the legislators approach me and offer various projects. The agents are Ruby Tuazon, Maya Santos, Patricia Gay Tan, Jen Corpuz and Allan Ruste among others. As agents they receive an estimate of 5-10% of the total project cost as their commission. The primary role of the agents is to follow up the agencies and legislators for the processing of the documents as well as the release of the funds. Some of the agents are named below:
 - a. Ruby Tuazon— I was introduced to Ruby Tuazon by his husband, Carlos Tuazon. She has a lot of contacts in the government because she used to be the Social Secretary of then President Estrada. Since then she would offer projects to me. Usually, she receives 10% to 15% commission.
 - b. ASEC Catherine May C. Santos—I was introduced to Maya Santos when she went to my office together with her boyfriend from customs named Jerry Cailan. She introduced herself as the chief of staff of Senator Manny Villar. She initially offered the PDAF of Senator Legarda. She usually asks for 10% commission while 40% will be given to the Senator she talked to. When she became the director of admin and finance of the Department of Agriculture, she offered more projects to me. She was very influential in the agencies because she was known there thus she was the one who would always follow up with the agencies. She would always boast about her connections as she is also married to Ino Santos who is the son of then mayor of Davao and sister-in-law of Bebot Bello, the former D.O.J. Secretary and Justice Antonio Nachura.

She usually gets her commission in cash. Though, at one time, I remember depositing 5 Million pesos in her Metrobank Jose Abad Santos account. It was during her tenure as the director at the Department of Agrarian Reform when she was able to send her daughter to school in London. She was also able to purchase a lot of vehicles and a newly constructed house in AFPOVAI where she currently lives in.

- c. Patricia Gay Tan -I was introduced to Patricia Gay Tan Alice Villanueva and Lourdes "Baby" Villanueva Reyes. She is the sister of Bibing Villacorta and their brother Atty. Yaki Tan (former PLLO), She is also the daughter of then Congresswoman Agana of Bohol. She offered PDAF projects and sold it to me. According to her, she has been engaged in projects using PDAF funds for a long time. Later on, I found out that she would always enter into projects that would turn out to have problems. I also found out that she would use the NGOs associated with me, so I would be the one to have problems. During the first time they offered to transact, they showed me a SARO. However, the SARO turned out to be fake when I had it verified. At one time, she also offered a one (1) Billion worth project coursed through DOTC using First Allied United Enterprises. Luckily, I never pushed through because after sometime I found out that they proceeded with the project with so many irregularities. She was also ZNAC Rubber Estate associated with Corporation Pangkabuhayan Foundation. I remember that in the case of ZNAC Rubber Estate, COA found out that using Pangkabuhayan Foundation and there was no delivery.
- d. Pauline Labayen—She is the chief of staff of Senator Jinggoy Estrada. As the chief of staff of the Senator, the agents would always follow up with her regarding the documentations. Eventually, she also

became the agent herself. She usually gets 5%-10% commission in the transactions. She is also the owner of tips and toes in Greenhills.

- e. Jennifer Corpuz—She was introduced by Pauline Labayen. She used to work for Jinggoy Estrada then formed a PR firm at Ortigas. She is the PR of Senator Sotto. Usually, she gets 10% commission.
- 21. Legislators—The agent negotiates the rebate of the legislators as they have agreed or the legislator would directly demand how much their share should be. Whenever I am not amenable with their demands, they would offer the project to someone else. Therefore, the rebate depends on the amount the legislator or the agent would demand. I really have no say as to the amount, since if I don't agree, they would just offer the project to someone else. The rebate used to be just 20%, which later on became 30% until 50% depending on what they demand. Aside from that, the legislator chooses which agency the funds will be coursed through.
- 22. Agency— The legislator chooses which NGO he chooses to partner with to implement the project as shown by the endorsement letter that they submit to the agency. The agency will not recognize the NGO unless the legislator endorses them. The agency enters into a Memorandum of Agreement (MOA) with the NGO and the legislator as to the project. The agency verifies, inspects and accredits the NGO before they do so to make sure that the said organization is legal and existing and compliant to the agency's requirements and guidelines. The check is also released via the agency's cashier after the proper liquidation papers are approved and submitted. Some agency requires a 3%-5% management fee as per the agency rules.
 - a. National Agri Business Corporation (NABCOR) Rhoda Mendoza (owner of Cams Tres Marias, which sells organic fertilizer operating at Sta. Maria Bulacan), Allan Javellana
 - b. Technology and Resource Center (TRC/TLRC) Antonio Ortiz, Dennis Cunanan

- c. National Livelihood and Development Corporation (NLDC) Alexis Sevilla
- The giving of the rebate of the legislator and commission of agent depends on the whim of the agent and the legislator. When the agents or legislators approach me, they usually show me a photocopy of the SARO or listing. At that point, the rebate of the legislator and the agent is given either in partial or in full. The photocopy of the SARO or listing shows that the project exists. When the original of the SARO is released by the DBM, sometimes rebate is also given to the legislator when we are given a copy of the SARO. In some cases, upon release of the Notice of Cash Allocation by DBM rebate is also given. Rebate is sometimes given when the final check is released by the agency.
- 24. Release of Government Funds— The MOA is entered into between the agency, legislator and NGO. The agency releases the fund appropriated for the project upon submission of the required documents. The funds are released in various tranches. Initially, fifteen (15%) of the fund, the mobilization fund, is released so that the NGO will be able to implement the project. During the implementation of the project, the agency representative accompanies the NGO representative to make sure the delivery/implementation is made. They monitor the delivery and implementation. The beneficiary of the project will be provided by the Local Government Unit (LGU), since the delivery is done to their constituents. Once the project is implemented and delivered, liquidation papers will be required by the agency, which the NGO complies with. In every delivery/implementation, the inspector will give the approval if the funds should be released depending on the report. Only when the agency approves the liquidation papers submitted will they release the appropriate check for 35% or 85% of the project cost. If only 35% of the fund is initially released, the 50% of the budget will be released only upon submission of a terminal report restating the delivery and implementation of the project. All the forms

and documents submitted to the agency are also provided by the agency and only filled up according to the details of the project as implemented.

- 25. **Post-** Audit— Only after the fund is released and the project is implemented will the COA conduct the audit.
- 26. *Computation of Expenses*—The table below shows the usual costing breakdown of the project, depending on the negotiation:

Legislator	40%-50%
Agent	5%- 10%
Agency	2%-15%
Production Cost	20%-35%
Profit and Operation Expenses	5%-10%

As a businesswoman, the venture was profitable since I get to keep 3% to 10% of the total project appropriation, which is shared with the NGO presidents and operation costs. To assure that we get to comply with the demands of the trade, we procure quality goods and services at a reasonable price. Thus, even if our production cost is limited to 20%-35% we are able to comply with the project requirements without sacrificing standards and quality. We also aim for volume so even if the profit is small, I still find it good business. In some cases, the project is breakeven. In some cases, I don't get to collect and earn from the project. Those are just part of the risk of being a businesswoman.

THE TRUTH ABOUT THE MALAMPAYA FUND

(OMB-C-C-13-0357, NBI vs. GLORIA MACAPAGAL ARROYO)

27. Sometime in 2004, Tet De Joya, Manager of Gentleman's Club located at the 40th Floor of Discovery Suites, went to my office at the 25th Floor of Discovery Suites together with Carlos "Butch" Tuason. Ms. De

Joya introduced me to Mr. Tuason as the cousin of then First Gentleman "FG" Arroyo. They asked me to help them, through my staff, to fix the car of Mr. Tuason, which was then parked at the basement parking. During our meeting, Mr. Tuason told me that he was in-charge of the projects as well as the PDAF of then Cong. Iggy Arroyo, brother of FG Arroyo.

- 28. Few days after, I was invited by Mr. Tuason to the house of Marilou Arroyo, sister of FG Arroyo, at the La Vista Subdivision in Quezon City. At that time, the house of Cong. Iggy Arroyo also in La Vista Subdivision was being constructed.
- 29. After the construction of Cong. Iggy Arroyo's house, I was again invited by Mr. Tuazon to La Vista Subdivision. This time I was introduced to Congressman Arroyo.
- 30. Mr. Tuason told me that he had a second wife named Ruby Chan Tuason. At that time, they were in trouble because he was unable to provide her monthly financial support for months. I did not believe him initially that he had financial problem with his wife Ruby Chan Tuason, because I knew him to be the cousin of FG and they came from a well-known wealthy family. Thereafter, he introduced me to Ruby Chan Tuason at the latter's house in Bel-Air, Makati. While in Bel-Air, they fought on financial matter even in my presence.
- 31. Mr. Tuason then asked Ruby to give me government projects to be sourced from the PDAF. He likewise asked Ruby to share him in the rebate which I would give.
- 32. Ruby then told me that she had lots of contacts in the government because she used to be the Social Secretary of President Estrada and also because she is the wife of FG Arroyo's cousin. At that time, the president was FG's wife, Gloria Macapagal Arroyo.

- 33. Ruby mentioned to me that she also refers to Bobby Rodriguez of Pangasinan some hard projects sourced from the PDAFs of some senators and congressmen.
- 34. After that brief meeting with Ruby at her house, she and Mr. Tuason went to my office in Discovery Suites offering to me the PDAFs of some senators and congressmen.
- 35. Thus, it was in 2004 that Ruby started to refer to me the PDAFs of lawmakers of which she asked to be paid 10% rebate, aside from the rebate being promised and given to her by the lawmakers, because that was also the percentage that she receives from Bobby Rodriguez. She mentioned the names of Patricia Agana Tan and Alice Navales Villanueva. She told me that the foundations they were using had problems, so she had to refer some of her projects to me.
- 36. I had several projects with Ruby involving the PDAFs of various lawmakers.
- 37. It was around November 2009, when Ruby showed me the list of government funds amounting to Php 25 Billion from Malacanang. She was then talking to a certain Medy Poblador while explaining at the same time the list of government funds. I saw in the list the Php 5 Billion Pesos project in the Department of Agriculture (DA), but she said she already referred it to another contractor.
- 38. Ruby then referred to me the Php 900 Million Pesos government fund, which will be coursed through the DAR. She handed over to me the SARO dated November 19, 2009. I was then reluctant to accept the offer considering the huge amount, but she told me her "boss" named "RR" is a Little DBM.

- She also told me that the funds will be released immediately because it would be used for the 2010 Presidential Election of then President Gloria Macapagal Arroyo's political party. She likewise said that she was in-charge of the TV advertisements of the Lakas Party. She asked me to send my staff to the DAR office and to call her should there be any problem in DAR so she could call Medy Poblador to fix the problem.
- 40. At that time, I did not know that the Php 900 Million Pesos fund was the Malampaya Fund. Even on recollection now, I don't think I was directly informed that the project will be utilizing the Malampaya Fund. We agreed that 60% rebate or Php 540 Million Pesos would go to her, 35% would be set aside for the purchase of goods to be delivered and 5% would be left for the foundation. Again, she said that the money would be used for the 2010 election.
- 41. In that computation, the foundation would get 5 % from the Php 900 Million Pesos or Php 45 Million Pesos.
- 42. I agreed to the proposed 60% rebate, considering our arrangements for the said project. She said, she would choose the LGU that they wanted to use since it will be election. She also took the responsibility of processing the documents and asking the signatories to sign documents which the DAR may require. My responsibility would be limited to the delivery of the goods of the LGU/End User. I only requested her to choose LGUs from nearby towns and provinces to make sure delivery would be easy.
- 43. When the documentation process was started, Ruby Tuason insisted to submit documents even if it is still incomplete and to just submit additional documents later. She told me not to worry because according to her Malacanang already instructed the DAR to speed up the release of the check.

- 44. When the check was released by the DAR, I asked Ruby about the implementation of the delivery. Ruby Tuason was the one who provided me the list of the ninety seven (97) mayors and their respective municipalities.
- 45. I also asked Ruby who would pick up the 60% or Php 540 Million Pesos, she told me to bring the money to her house in Zagu St., Dasmarinas Village, Makati City which she was then renting.
- 46. When the money was delivered to Ruby, I asked her the names of the coordinators in order to arrange the delivery of the goods. But she said she would just get back to me. Few days later, Ruby went to my office asking for the 35% or Php 315 Million originally intended for the purchase of the goods to be delivered to the beneficiaries. She told me that the deliveries should be made in cash instead of goods to the Mayors because they wanted funds for their election campaign.
- 47. At first, I refused to release the said amount because I already used part of the money to pay the raw materials needed for the delivery. Ruby insisted and told me that the end users would not accept the goods even if I insist to deliver. I felt trapped at that time because if I don't give in to her request, I won't be able to comply with the liquidation requirements. Thus, I was forced to hand her the 35% because I did not want to have problems later on. After delivering the money, she gave me the beneficiary list for the project.
- 48. During the transaction, whenever I requested Ruby to follow up about the documentation of the project, I often hear her talking to a certain Medy Poblador to follow-up.
- 49. Around the period of the Php 900 Million Malamapaya Fund project, Ruby was able to build a Three Hundred Million Pesos (Php

300,000,000.00) worth house in Dasmarinas, Village along Mahogany Street.

THE TRUTH ABOUT THE FILED CASES

In OMB-C-C-13-0396 (FIO vs. Juan Ponce Enrile, et.al.) and OMB-C-C-13-0318 (NBI vs. Juan Ponce Enrile, et.al.), the following transactions occurred with the Office of Senator Juan Ponce Enrile ("Sen. Enrile"):

- 50. In SARO # 07-04618, the amount is Twenty Million Pesos (Php 20,000,000.00) the agency is TLRC.
 - 51. The computation of commission herein provided, to wit:

- 52. The advanced payments given to Sen. Enrile and Ruby were made upon listing. The commission of Sen. Enrile and Ruby were picked up by Ruby in my office in the Discovery Suites (Unit 2502). I remember she wore a black duster type dress accented with pashmina shoal. I personally handed the cash to Ruby amounting to Ten Million Five Hundred Sixty Thousand Pesos (Php 10,560,000.00). She asked that the cash for the Senator Enrile be placed in a box (Php 8,640,000.00) while her commission be placed in her bag (Php 1,920,000.00).
- 53. I personally met Director Antonio Ortiz in Pancake House in Malayan Building in Ortigas to give him his commission of One Million Nine Hundred Twenty Thousand (Php 1,920,000.00), he was wearing a long sleeve shirt and brown slacks and came around in a black pickup. Dennis

Cunanan was met by my nephew John Lim at the Ford Showroom in Edsa Greenhills for his commission of Nine Hundred and Sixty Thousand (Php 960,000.00). Both Ortiz and Cunanan's commission were given before they would release the check to the foundation since I was told that they would not release the check unless they will get their commission first.

- 54. In SARO # ROCS-08-01347, the amount is Twenty Five Million Pesos (Php 25,000,000.00) and the agency is DA-NABCOR.
 - 55. The computation of commission is herein provided, to wit:

- Twenty Five Million Pesos (Php 25,000,000.00) she told me that she will be meeting with her contact in the office of Senator Enrile later in the day and she needs to close this deal to sell the SARO before that. She insisted that I produce the necessary cash so she can relax and not stress about it anymore. She told me that if I decline, she will be meeting with Patricia "Gay" Agana Tan later in the day to convince her to produce the money instead. I checked my finances and was able to come up with the amount. I placed the cash in two separate bags and handed it to her.
- 57. I sent Rhoda Mendoza and Dir. Allan Javellana's portion to their office thru one of my staff. I placed the cash in two separate paper bags containing Two Million Five Hundred Thousand Pesos (Php 2,500,000.00) for Director Javellana and One Million Two Hundred Fifty Thousand Pesos (Php 1,250,000.00) for Rhoda Mendoza.

- 58. In SARO # ROCS-09-00804, the amount is Twenty Five Million Pesos (Php 25,000,000.00) and the agency is DA-NABCOR.
 - 59. The computation of commission is herein provided, to wit:

- 60. For this transaction I met Ruby Tuason in the lobby of Discovery Suites. She was together with her driver and maid. I placed the entire amount of Thirteen Million Seven Hundred Fifty Thousand in a printer box to make it less conspicuous. I instructed one of my staff to meet Rhoda Mendoza in the Starbucks at the Philippine Stock Exchange Building in Ortigas and handed her two paper bags containing One Million Two Hundred Fifty Thousand (Php 1,250,000.00) for Rhoda Mendoza and Two Million Five Hundred Thousand Pesos (Php 2,500,000.00) for Director Javellana. Rhoda Mendoza gave me a call when she received both paper bags.

When she left I escorted her to the lobby of our condominium with her and saw her board a Toyota Camry.
- 68. Ruby called and said that her driver "Al" will go to my office in 2502 Discovery Suites to pick up the balance of the commission. She said she will not go up to my office anymore since she needed to rush and meet someone. Her driver, Al, arrived and I handed him a sealed computer box for the Senator containing Ten Million Nine Hundred Twelve Thousand Five Hundred Pesos (Php 10,912,500.00) and a paper bag containing Two Million Four Hundred Twenty Five Thousand (Php 2,425,000.00) for Ruby. 
